## HARBOR RULES AND REGULATIONS

### SECTION A: MOORINGS

1. Mooring permits are valid for one year. A copy of the boat registration and a new application must be filed at the village hall each year a mooring is placed in village waters. No mooring shall be placed in Laurel Hollow waters unless by an approved inspector, as listed below.
2. The mooring permit application should be completed by the boat owner. A mooring number may be obtained by calling the Harbor Master. The number assigned should be placed on the application and painted on the mooring. Whenever possible the same mooring number will be reassigned; however, the Harbor Master must confirm this each year.
3. Moorings may not be winter staked or otherwise remain in place over the winter. A new pennant must be used every year. Mushroom, chain, shackles, swivels and buoys must be inspected every year before placement. Approved inspectors must make inspections for the current year as listed in Section E. The inspector must have a completed Laurel Hollow mooring application from the boat owner before the mooring is placed in Laurel Hollow waters. The application should be submitted to the Harbor Master bearing the inspector's stamp and signature, indicating the mooring is satisfactory, within twenty-four (24) hours after the placement of the mooring.
4. In the event any mooring is still in the water after December 1st, the village will arrange for its removal, and the owner shall pay for the actual costs of such removal, plus \$100 to cover the administrative costs of the village.
5. Mooring suffixes have the following significance:
  - A) North of the village beach
  - B) East of the beach and east of the village hall
  - D) South of the village hall and north of the sand spit

Except for these general designations, the assigned numbers bear no relation to the mooring location. Moorings may be placed anywhere within the designated area, provided the minimum distances specified in Section D are maintained.

6. The spacing between an adjacent mooring, shown in Section D, is governed by the larger of the two boats. If, at the time of mooring placement, there is a nearby mooring with no boat attached to it, it is the responsibility of the boat owner to determine its size and to space his mooring appropriately. The size of the boat assigned to any mooring can be obtained from the Harbor Master.
7. In the event that two moorings are closer together than permitted by the regulations and either of the owners objects, the owner of the mooring placed at a later date will be required to move his mooring at his own expense.

8. Experience has shown that the mooring configuration and sizes specified in Section D define a system that has adequate strength, produces a spacing appropriate to the village boat density and water depth, and has high enough visibility to minimize fouling by other boats. Other types of moorings will be approved only if, in the judgment of the Harbor Master, they meet these same criteria. Non-standard moorings should be discussed with the Harbor Master before placement.
9. There is no fee for placing a mooring in the village waters.
10. No Mooring should be placed before April 15<sup>th</sup> or as prescribed by the Harbormaster.

### **SECTION B: FLOATING DOCK**

1. The maximum tie-up time to any part of the dock is 10 minutes.
2. Disabled vessels may be tied up for up to 24 hours to faces other than the outer face, provided permission is secured from the Harbor Master, Deputy Harbor Master, or the Oyster Bay Cove Police Department.

### **SECTION C: DINGHY STORAGE**

1. Dinghies and other small boats/vessels (including but not limited to kayaks) stored on racks at the village hall must have the current year's sticker attached. Stickers may be purchased by mail. Applications are available at the village hall.
2. The Harbor Master will notify residents by telephone of their assigned dinghy/vessel/small boat space after being notified by the village hall that a sticker has been purchased.
3. The assigned location will depend upon dinghy/vessel/small boat dimensions. Rack location numbers bear no relation to sticker numbers.
4. Boats on racks may not exceed 15 feet in length.
5. Dinghies and small boats/vessels must be properly secured in their assigned rack location at all times.
6. **Dinghies and boats/vessels must be removed from the racks by December 1st and may not be installed before April 15<sup>th</sup>.**
7. The Clerk will provide email notice to the permit holder advising them that the Village will remove, or cause to be removed, any dinghy or other boat / vessel, which is not properly secured in its assigned rack or which is remaining on the rack after December 1st. The resident / permit holder / owner of any dinghy or other boat / vessel so removed shall pay a removal fee of \$200 plus an initial storage fee of \$200. An additional storage fee of \$200 will be charged for each month that the dinghy or other vessel remains unclaimed.



The resident / permit holder / owner of a dinghy or other boat/vessel removed by the Village will not be eligible for new permits, including, but not limited to parking and dinghy permits, unless and until the dinghy or other boat/vessel is redeemed from storage and all removal and storage fees are paid. If the dinghy or other boat/vessel is not redeemed by April 15th of the following boating season it shall be deemed abandoned and the Village may dispose of same without liability. The Village is not responsible for any boat/dinghy or other vessel that it removes, nor shall it be responsible for any dinghy or other boat/vessel while in storage.

Further, the owner of such dinghy or other boat / vessel may be subject to the provisions of Section 140-14 of Chapter 140 entitled "Waterways" of the Code of the Village of Laurel Hollow, **with a maximum fine of \$1,000. / 15 days imprisonment for each day; each day being a distinct and separate violation.**

## Harbor Rules & Regulations

1. The sizes and spacing are minimal and should be increased if the mooring is placed in deep water or if the superstructure is unusually large.
2. Buoys must be white and project 15 inches above the water surface. The assigned mooring number, or the name of the owner, as well as the symbol "P" (power) or "S" (sail) and length (in feet) of the boat must be placed on it in black, using letters and numerals at least 2 ½ inches high.
3. The distance between any mooring mushroom and the village beach or the village dock must be at least 200 feet.
