BUILDING REPORT

Trustee Nicholas Tsafos

Building Permit Amendment Fees and Unified Solar Permit Fees: Building Superintendent McNerney explained that when the Board increased the Building Department fees, the amendment fee and solar permit fees were not included. Mr. McNerney proposed that these fees now be increased as follows so that all Building Department fees will be uniform across the board:

- Unified Solar Permit increase from \$370.00 to \$650.00 and the per \$1000 cost from \$15.00 to \$17.50
- Building Permit Amendment Fees increase the amendment fee from the greater of \$250.00 flat fee or \$15.00 per \$1000 to greater of \$250.00 flat fee or \$17.50 per \$1000

Mayor DeVita moved to approve the foregoing fee increases as recommended, seconded by Trustee Novick and approved upon the following poll of the Board:

Applications for Driveways: Building Superintendent McNerney explained that if a resident applies for a Building Permit for driveway work which touches the Village right of way, a separate Street Opening Permit is currently not required. As a result, the Village has no cash deposit to go against if damage occurs to the right of way. Mayor DeVita moved to require that any Building Permit application for driveway work which comes into contact with the right of way must be

accompanied by a separate Street Opening Permit with all the required fees and cash bond, seconded by Trustee Jusko, and approved upon the following poll of the Board:

Driveway work at 1499 Laurel Hollow Road: In connection with the previous discussion on driveway work, the resident at 1499 Laurel Hollow Road installed a Belgian block driveway apron that did not properly meet the public road as determined by Building Superintendent McNerney and Village Engineer Antonelli. The Board determined that United Paving shall perform the repair work and the cost of such repair work will be deducted from the resident's cash deposit.

FILM PERMIT

The Board considered a film permit application by Vertical Hold Productions LLC to film a scene from the television show "Prodigal Son" at 536 Cold Spring Road. Representatives of the applicant Shannon Blaney and Morgan Roche and Mr. Vincent Polsinelli, the homeowner, were in attendance to present the application. The applicant informed the Board of relevant particulars: (a) a separate private lot will be used to park large trucks, (b) some visual effects might be used to simulate fire, and (c) the property, which is on four acres, is large enough so that surrounding residents will not be disturbed. Police Chief Cronin suggested Fire Department presence and discussed the police fees. Further discussion ensued. There being no further discussion, Mayor DeVita moved to approve the permit to film at 536 Cold Spring Road for three days, for a permit fee of \$7,500.00 (\$2500 per day), and with extended time to midnight, with the following conditions:

- filming is not to extend past midnight
- if filming extends beyond three days, the per day charge is \$2,500 as per the ordinance
- permit holder is to be responsible for police costs as calculated in a separate agreement with the Village of Oyster Bay Cove,
