BUILDING REPORT - STATUS OF BUILDING PERMIT #3150 for BITON

This building permit was extended until June 25, 2022 by the Board at their meeting on May 11, 2022. The Building Inspector reported that the work covered by this building permit is now complete. The Planning Board Chairman reported that the required plantings have been installed

to the satisfaction of that Board. However, it was noted that the grass seed was only just planted and the premises still appear bare and full of dirt. The Board was concerned not only about the appearance of the property, but about the potential for runoff in the sloped area between the fence and Springwood Path. The runoff of sediment could potentially clog Village catch basins.
