# **RESIDENTS' CONCERNS**

Mr. Joe Cesar, Waylor Lane, spoke to the Board about his concern that the Highway crew had plowed the snow in front of his driveway instead of at the head of the cul-de-sac. # PUBLIC HEARING ON LOCAL LAW 1-2021 (introductory Local Law A-2021)

Mayor DeVita opened the public hearing at 6:12 pm on Local Law 1-2021, authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c.

Mayor DeVita explained that the law has been passed every year whether or not utilized, in the event the State-mandated tax cap is exceeded for the next fiscal year's budget and to protect the Village in case of an unforeseen need to exceed the tax cap. Enactment of the law requires a vote by a super majority of the Board.

#### **ENGINEER'S REPORT**

Village Engineer Antonelli indicated that he is ready to go out to bid on the roads for the Spring, but he is waiting for the snow to melt.

#### RESOLUTION TO ADOPT NASSAU COUNTY HAZARD MITIGATION PLAN

Village Engineer Antonelli reported to the Board that a questionnaire had been distributed last summer, requesting municipalities to submit a 5-year hazard mitigation plan, which Laurel Hollow completed and submitted to the County. This plan, which included mitigation tasks to control flooding on Laurel Hollow Road and to protect the seawall, was submitted to the County for inclusion in its overall Hazard Mitigation Plan. The Board has been asked to adopt the County's Plan so that the Village may gain access to FEMA mitigation funds if they become available. Village Engineer Antonelli pointed out that an error was made in the Laurel Hollow section—it is

stated that the Village does not have an NFIP Ordinance when in fact it does in Chapter 57 of the Village Code. Trustee Nicklas moved to adopt the following resolution, which includes language that the County should revise the Laurel Hollow section of the Plan to correct for the error just noted, seconded by Trustee Tsafos, and approved by the following poll of the Board:

**WHEREAS** all of Nassau County has exposure to natural hazards that increase the risk to life, property, environment, and the County's economy; and

**WHEREAS** pro-active mitigation of known hazards before a disaster event can reduce or eliminate long-term risk to life and property; and

**WHEREAS** The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre- and post-disaster hazard mitigation programs; and

**WHEREAS** a coalition of Nassau County municipalities with like planning objectives has been formed to pool resources and create consistent mitigation strategies within Nassau County; and

**WHEREAS** the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of natural hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating, and revising this strategy.

# NOW, THEREFORE, BE IT RESOLVED that the Village of Laurel Hollow:

- Adopts in its entirety, the Nassau County Hazard Mitigation Plan (the "Plan") as the Village of Laurel Hollow's Natural Hazard Mitigation Plan and resolves to execute the actions identified in the Plan that pertain to this Village.
- 2) Will use the adopted and approved portions of the Plan to guide pre- and post-disaster mitigation of the hazards identified.
- 3) Will coordinate the strategies identified in the Plan with other planning programs and mechanisms under its authority.
- 4) Will continue its support of the Mitigation Planning Committee as described within the Plan.
- 5) Will help to promote and support the mitigation successes of all participants in this Plan.
- 6) Will incorporate mitigation planning as an integral component of government and partner operations.
- 7) Will provide an update of the Plan in conjunction with the County no less than every five years.
- 8) The BOT approved the Nassau County Hazard Mitigation Plan, with the condition that the County revise the plan in the Village of Laurel Hollow section, where the table of

Regulatory Tools, on page 3 of the Village section, indicates that the Village does not have an NFIP ordinance, when, indeed it does, in Chapter 57 of the Village Code
