 Building Amnesty – the Board discussed a proposed Building Amnesty Program to encourage residents to apply for building permits to maintain construction performed without required permits in order to bring these conditions into compliance. The imposition and collection of the additional building permit fees required by Sec. 23-3(F)(1)(e) of the Village Code, which are imposed for work performed without the necessary building permit(s), shall be suspended from June 1, 2021, until November 30, 2021. During this period, all other fees imposed pursuant to Sec. 23-3(F) shall remain in full force and effect. This suspension shall apply only with respect to building projects completed before June 1, 2021, without the required permits.

Suspension of the fees as set forth above shall not be available to:

- (1) any applicant for a building permit to whom a Notice of Violation or Village Court Appearance Ticket has been issued concerning the construction work in connection with such application and such matter remains pending at the time such application is made.
- (2) any applicant for a building permit who has been assessed a monetary fine in the Village Court concerning the construction work in connection with such application and such fine remains unpaid in whole or in part.
- (3) any homeowner who has not fully paid all Village taxes due and owing at the time the application for a building permit is filed.

Any building permittee who paid the additional building permit fees required by Sec. 23-3(F)(1)(e) of the Village Code after December 1, 2020, shall be eligible for a refund in the amount of \$250 of the additional fees that were paid in full pursuant to that section. This refund shall not be available to a contractor, but only to the homeowner. If the building permittee no longer owns

the otherwise eligible premises, then no refund shall be allowed to the former owner who in fact paid the additional fees.

Any applicant for a building permit who believes that the provisions of this resolution create an undue hardship may apply in writing to the Board of Trustees for relief.

Solar Panels – due to an increased interest in installing solar panels, Mayor DeVita discussed
whether the appearance of the panels should be regulated. The Board believed that
regulation is not necessary at this time.
