The largest road reconstruction project in the Village's 93-year history is nearly complete. Other than punchlist items (removing debris, correcting driveway aprons, problem water spots, etc.) and the repaving of Cherry Lane and a portion of Moore's Hill Road (which will take place in the Spring 2020), more than 60% of our roads have been repaved and received new curbing in the past 15 months. Congressman Suozzi reached an agreement with air traffic controllers to bring the planes in for landing at higher altitudes over the north shore to reduce noise. However, the Federal Aviation Administration suspended that agreement indefinitely for further study. **REMINDERS**



**TREES**

Please remember to call Village Hall before removing trees. Permits are required to remove all trees that meet the size threshold and are not 100% dead. Photographs must be submitted to the Village before dead trees may be removed. Applications for tree removal may be obtained at the Village website under the tab of “Forms & Instructions.”

**SCOOP THE POOP!**—We have had complaints from residents--and even our Village Engineer--about people failing to clean up after their dogs in the streets. In addition to the fact that cleaning up after your pet is the law, leaving your pet’s poop on the ground presents ecological problems. Dog feces contain bacteria which filters to the water table or makes its way to the Long Island Sound. An interim water testing report done by Stonybrook University identified bacteria from animal waste as being one of the sources of our--at times--high bacteria readings at our beach. Don’t undo the water-purifying benefits of tens of thousands of oysters planted in our waters by scores of your friends and neighbors—our oyster gardeners. Remember to clean up after your pet.

**POLICE CALLS**

Finally, please remember to **call 911 immediately** in the event of any emergency. Whenever you see a suspicious car or need to report suspicious events, **call 911**. Do not call the Village Hall or the Oyster Bay Cove police booth for an event because the police booths, both in Laurel Hollow and in Oyster Bay Cove, are not staffed 24/7 and it will only delay a response. However, if you want to alert the police, for example, that you will be away for the holidays or vacation, then call the police booth at (516) 922-6363.
