

PUBLIC NOTICE: INC. VILLAGE OF LAUREL HOLLOW – PLANNING BOARD

NOTICE IS HEREBY GIVEN, that public hearings will be held by and before the Planning Board of the Inc. Village of Laurel Hollow, Nassau County, New York, on Mon. September 21, 2019 at 7:00 P.M. to consider the following:

- **P2-2020 & T5-2020 ~ Public hearing on the application of Tomy & Jill Biton, 16 Springwood Path, Laurel Hollow, for approval to remove 7 trees in connection with an Excavation Permit to regrade an area of the property to create more flat, usable space. This parcel of land is known as Section 14, Block 25, Lot 28 on the Nassau County Land and Tax Map.**
- **P8-2020 & T34-2020 ~ Public hearing on the application of Marisa & Richard Cuccia, 26 Vista Drive, Laurel Hollow, for approval to remove 19 trees some of which are considered to be in poor health and to allow for planned landscaping of the property. This parcel of land is known as Section 25, Block 64, Lot 15 on the Nassau County Land and Tax Map.**
- **P9-2020 & T32-2020 ~ Public hearing on the application of Gareth & Victoria Roberts, 88 White Oak Tree Road, Laurel Hollow, for approval to remove 12 trees which are either considered to be in poor health, too close to the house or to create a clearing. This parcel of land is known as Section 25, Block 49, Lot 15 on the Nassau County Land and Tax Map.**
- **P10-2020 & T37-2020 ~ Public hearing on the application of Kristopher Koka, regarding a newly created lot formerly *part of* 1234 Moore's Hill Road, Laurel Hollow, for approval to remove 63 trees and approval to disturb slope, very steep slope and severely steep slope in connection with the construction of a new single family home. This parcel of land is known as Section 26, Block C, part of Lot 124 on the Nassau County Land and Tax Map. **ADJOURNED****
