SQUATTERS

The Board discussed means by which the Village could prevent repetition of the squatter incident that occurred at the home on Route 25A. It was suggested that rentals be registered with the Village and new owners could be required to notify the Village within 30 days of taking ownership that the home might be vacant or potentially rented to a third party. Real estate agents could be advised of this requirement at the time of a sign permit application. The legislation would be discussed at the next regular meeting.

ENGINEER'S REPORT

Village Stormwater Program

Board members reviewed the Engineer's Report concerning the Village Stormwater Program. The Clerk/Treasurer reported that no comments had been received regarding the Draft Stormwater Management Program Annual Report Year 2020, prepared by the Village Engineer, which had been posted to the website and available at Village Hall for public comment. Mayor DeVita reported on the Greater Long Island Running Club's letter to the Village, advising that the club's Ocean to Sound Relay (OSR) would be traveling along Rte. 25A and avoiding local Village roads. The Mayor recounted how permission to run the race through the Village including 25A was revoked years ago because of lack of safety and liability concerns. Given the complete disrespect and refusal to comply with the Village's disallowal of the OSR, Mayor DeVita proposed revoking the permission given to GLIRC for its August 30th Triathlon bike leg through Village roads.
