BUILDING REPORT

ENGINEER REPORT

The Board considered Street Opening Permit #4-2018 for a water main connection for 32 Hilltop Road. Mr. Cartagena and Michael Rant, P.E. were in attendance to address the Board's questions. Mr. Rant explained that the only way to connect to the existing water main is to open the road, and he requested an exemption from the requirement for directional boring. Mayor DeVita moved to approve the Street Opening Permit #4-2018 with the following conditions:

- 1. The work shall be in strict compliance with the Water Service Road Opening Plan prepared by NorthCoast Civil, dated 8/25/2020;
- 2. The excavation must include removal of the soil below the water main in order to expose the pipe to accommodate use of a saddle and to make a clean tap for the house service connection;
- 3. The concrete curb shall be adequately supported in a manner approved by the Village Engineer while the connection is being made;
- 4. The trench backfill shall be compacted with a mechanical tamper in 6-inch lifts;
- 5. The inner edges of the saw cut opening shall be brushed with an asphalt sealant to seal the patch from below;
- 6. The asphalt must be flush to all adjoining pavement and compacted to an even finish without waves or ridges;
- 7. "Premium" asphalt mix per specification provided by the Village Engineer shall be utilized (or if not available a comparable substitute approved by the Village Engineer shall be utilized):
- 8. Permittee shall provide a total escrow payment in the sum of \$5,000 (\$3,000 has already been deposited, which leaves a balance of \$2,000) to ensure that the work is performed to the satisfaction of the Village;
- 9. All work under this permit shall be performed by a contractor to be selected by the Village.

- (b) only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.
