# INC. VILLAGE OF LAUREL HOLLOW MOORING PERMIT INSTRUCTIONS

**ALL MOORINGS IN THE VILLAGE OF LAUREL HOLLOW MUST FOLLOW THESE PROCEDURES: NOT JUST THE ONES OFF THE VILLAGE BEACH & DOCK.**

1. Applicant obtains and completes Mooring Permit Application – Parts I & II.
2. Applicant calls the Harbormaster (w) 631 957-3467 or (h) 516 367-2305 to obtain Mooring #. (This number is likely to be the same as last year's number; however, there is no guarantee.)
3. Applicant forwards application (with mooring #) to an APPROVED Mooring Inspector from the list below. **ABSOLUTELY NO MOORING MAY BE PLACED BY A NON-AUTHORIZED MOORING INSPECTOR.**
4. Once mooring is installed by authorized inspector, Part III of application is completed by Mooring Inspector, who then:
  - Faxes it to the Harbormaster (f) 631 957-1005; and
  - Returns original form to the applicant.
5. Applicant submits fully completed application **and** photocopy of boat registration to the Village Hall within **2 WEEKS** of mooring being installed. **REGISTRATION MUST MATCH THE BOAT BEING MOORED.**
